


The aim is to gather the equality officers or delegates in charge of equality in higher education and research and promote gender equality in the French universities.

2. A lack of quantitative and qualitative studies >to share research results with others countries

Currently: A national French survey called VIRAGE, Violences and Gender Relations. Contexts and Consequences of Violence against Women and Men (INED)

- * About all forms of gender-based violence suffered over the previous 12 months and over their lifetime
- * Context and circumstances: workplace, in educational settings, public spaces, family, in the domestic space

2 complementary components:

- * A main large-scale survey by phone : 25 000 men and women (20-69)
- * A parallel survey online, using the same questionnaire, targeting specific populations, particularly students in 4 Universities

The aim of this panel is

- to provide an overview on the whole process of sexist behavior and sexual harassment
- to present some measures implemented, highlighting
 - the contexts,
 - the type of violence covered,
 - and the resistances
 - as well as the leverage.
